Enclosed are 7 copies of a letterhead memorandum incorporating information which was received from the Swiss Central Police Bureau, Bern, Switzerland, on 10/4/62. There are also enclosed for the Bureau photographic copies of the hotel registration forms filled out by TOURINE and LANGLEY at Lausanne and Clarens. In addition, a photograph of JOHN PULLMAN is also enclosed for the Bureau. It is requested that the photograph be copied for any additional inquiry determined feasible concerning him and that the original photograph be returned to this office for transmittal to the Swiss Central Police Bureau at their request. X (u)

We have requested the Swiss authorities to attempt to ascertain the exact numbers called on the dates indicated in the enclosed memorandum. X (u)

Swiss authorities have requested that inquiry be made by the Bureau and Canadian authorities in an effort to develop additional data concerning JOHN PULLMAN. It is requested that Bufiles be searched and that Legat, Ottawa make appropriate inquiries in this regard inasmuch as the information has been specifically requested by the Swiss, as well as in view of the fact that information developed may be of assistance to Bureau investigation in this matter. X (u)

Any additional data developed in this matter will be promptly furnished to the Bureau and interested offices. u
