It is noted that in the past the same informant advised that another of the subject's aberrations is stealing articles when he goes into stores. He has a compulsion to steal even though in many instances the article is insignificant in value.

Through liaison the Bureau has furnished the Swiss Police with the Identification records of the subject since he periodically visits Switzerland. The Swiss Police in the event of another visit by the subject will now take steps to have him banned upon arrival.
