Re Legat letter dated 11/6/68, and Bureau letter dated 11/15/68.

Enclosed is the original and five copies of LHM concerning the subject. It does not appear that the CHARLES WHITE, who holds US Passport Number 1000636, issued 7/8/68, is identical to the subject. Furthermore, he does not have a current or a former wife named DOROTHY. In addition, the NYO does not know TOURINE to have visited Italy recently.

It is not necessary for Legat to maintain stop placed with the Italian police on the subject at this time. In the event any contemplated travel to Italy is learned on the part of the subject, Legat will be immediately advised, and all pertinent information will be forwarded.

Washington Field will check US Passport Number 1000636 issued 7/8/68, in the name of CHARLES WHITE, who was born 5/28/05. It is believed by the NYO that this CHARLES WHITE is not identical to the subject. Furthermore, this CHARLES WHITE and the subject have different dates of birth, and usually the subject in the past has obtained a passport in the name of CHARLES TOURINE.
