The following information was received from the Police Judiciaire (Criminal Investigative Division) of the Sûreté Nationale (PJSN) on July 19, 1963:

Investigation at Beaulieu, France, revealed that the telephone number 820001 is registered to the restaurant in the Hotel La Reserve. The President and Director General of this restaurant is JEAN JACQUES LAROCHE, born January 23, 1904, at Ghent, Belgium. He is of French nationality and presently resides at 16 Alfred de Vigny, Paris. The manager of the Hotel La Reserve is one JEAN POTEFER, born May 6, 1908, at St. Hilaire (Seine et Oise), France. He resides at the Villa Sylvana, Beaulieu (Alpes Maritimes), France. (u) (X)

Investigation at Cannes, France, revealed that telephone numbers 393391 and 380391 at Cannes are listed to the same subscriber, one FRANK WILSON, born May 5, 1914, France at L'Ile Maurice. He presently resides at Palais Faustina, La Croisette, Cannes. His legal residence is 30 Edouard Square, London W. 8, England.

None of the above individuals are known in the files of the PJSN.
