THE FACT THAT THIS INFORMANT HAS BEEN INTERVIEWED SHOULD NOT BE DISSEMINATED OUTSIDE THE BUREAU. HE FEELS HIS LIFE AND THAT OF HIS FAMILY WOULD BE PLACED IN JEOPARDY IF KNOWLEDGE OF HIS INTERVIEWS AND COOPERATION WITH THE FBI WERE EVEN SUSPICIONED BY THE VARIOUS MEMBERS OF THE WASHINGTON, D.C. AREA GAMBLING ELEMENT.

This will confirm the telephone conversation between the Alexandria RA and the Baltimore Division 6/6/63.

RH 95-C-TE, on 6/6/63, advised that JOE NESLINE and "SPORTY" MARTIN (FRANK B. MARTIN), are holding the grand opening of a new dice game during the evening of 6/7/63. This game is to be operated at the Sportsman's Club, located on route five near Waldorf, Md. They have obtained protection from unidentified local law enforcement officials and contemplate remaining at that location for an indefinite period of time.

NESLINE and MARTIN have reportedly spent quite a lot of money in remodeling and furnishing the place, which was described to the informant as very plush.
