THE FACT THAT THIS INFORMANT HAS BEEN INTERVIEWED
SHOULD NOT BE DISSEMINATED OUTSIDE THE BUREAU. HE FEELS HIS
LIFE AND THAT OF HIS FAMILY WOULD BE PLACED IN JEOPARDY IF
KNOWLEDGE OF HIS INTERVIEWS AND COOPERATION WITH THE FBI WERE
EVEN SUSPICIONED BY THE VARIOUS MEMBERS OF THE WASHINGTON, D.C.
AREA GAMBLING ELEMENT.

RH 95-C-TE, on 6/10/63, advised that he did not attend the "so called grand opening" of NESLINE's new gambling venture, located on Maryland State Route 5, nine miles from Waldorf, Md., on 6/7/63. He later discussed this grand opening with WALTER J. ARNOLD, operator of the Boulevard Texaco service station, 600 Tenth St., Alexandria, Va., who was present during that evening. ARNOLD advised that the Sportsmen's Club is located next door to Black's Steer and Beef House, and is located in St. Mary's County, Md. ARNOLD stated that, according to "SPORTY" MARTIN, absolute protection has been obtained and they contemplate operating for a long period of time.
