LV 117-C maintained daily contact with NESLINE and furnished the Las Vegas Office information concerning his whereabouts. The informant advised that NESLINE told him that he was in Las Vegas only for the purpose of a vacation and that he had nothing going for him at the present time and was inactive. NESLINE also told the informant that he had been having trouble with his head and that he had been spending a great deal of time in bed.
