This information is not being repeated herein since captioned matter pertains only to the arrest of NESLINE, TOURINE and associates by state authorities in St. Mary's County, Maryland and their subsequent indictment by Federal Grand Jury in Washington, D.C. on 5/13/65, for violation of Federal and District of Columbia gambling statutes.
