Information received from confidential informants is being reported in the Anti-Racketeering case, and in accordance with Bureau regulations, is not set out in details of this ITAR report.

On 7/9/63, Miami Confidential Informant MM 869-PC advised SA C. GRAHAM HURST he had heard subject NESLINE, CHARLES TOURINE, and a third individual from St. Marys County, Md., were recently convicted of local gambling charges in Md. Source heard that the third individual is the man who allegedly put in the "fix" for this gambling operation. This third individual was understood to be very close to a "millionaire" and it was through this millionaire that the third individual had put in the fix, except of course, for the arresting officer. Informant heard that the millionaire was very upset and they were afraid he was ready to tell everything to the FBI.

From the foregoing and information previously developed, it was apparent that the "third individual" was ALLEN CHARLES FISHER and his millionaire friend PHILIP E. GRAY who owned the Sportsman's Club Restaurant and the buildings in which NESLINE and his associates were arrested for gambling on 6/13/63. GRAY was interviewed on 7/19/63 and the results incorporated into an FD-302 and included in the details of this report.

On 7/11/63, Confidential Informant WF 1108-C advised SA JOHN R. BUCKLEY that subject NESLINE has been spending a substantial amount of time at his residence, 1903 Chillum Road, Avondale, Maryland, during the previous two weeks. GEORGE ROHANNA was a frequent visitor to NESLINE's residence during the period. Informant advised that NESLINE planned to attend the Marlboro Race Track during the current meeting and that NESLINE would probably accept wagers from the numerous gamblers, and bookies would be in daily attendance at that track. Informant said that although NESLINE had been to race tracks frequently during the past few months (Rosecroft and Laurel Raceways), he seldom bets on the races.

On 7/17/63, WF 1108-C advised SA BUCKLEY that NESLINE had been living in the District of Columbia for the previous few days to avoid harrassment by Maryland law enforcement officials and constant visits and calls from members of the area gambling fraternity.

On 7/25/63, WF 1108-C advised he had learned that NESLINE had been staying with CHARLES TOURINE at the Appolline Apartments, 1330 New Hampshire Avenue, N.W., on an intermittent basis for the past two weeks. Informant knew of no gambling activity being conducted by NESLINE and TOURINE at present.

Cpl. E. M. EVANS, Maryland State Police Outpost, Prince Frederick, Md., advised SA EDWARD L. TIMMERMAN that on 7/30/63he contacted a Mrs. JOHNNY MAY MC DONALD, 419 Fifth Street, North Beach, Md. Mrs. MC DONALD, a widow, age 64, advised Cpl. EVANS that she has a 1950 Chevrolet Coupe, Md. Registration DY 65-71, that this car was not at the Sportsman's Club, Charlotte Hall, Md., on 6/7 or 6/8/63, and that no one else used her car on those dates.
