CHICAGO DIVISION - At Chicago, Illinois

Will contact officials of the Rudd Manufacturing Company to determine the whereabouts of A. T. BRILL in order that he may be interviewed concerning information he may have about DOLAN.

DENVER DIVISION - At Denver, Colorado

Will consider sending photographs of DOLAN to all auxiliary offices to assist in identification.

EL PASO DIVISION - At El Paso, Texas

Will attempt to secure, through boxing sources, information concerning DOLAN which might assist in his apprehension.

PITTSBURGH DIVISION - At Pittsburgh, Pennsylvania

Will attempt to locate A. P. BRILL and interview him regarding his association with DOLAN in an effort to obtain information which may assist in the apprehension of DOLAN. It is to be noted BRILL gave his address while in Phoenix as the Schenley Hotel, Pittsburgh.

SAN DIEGO DIVISION - At San Diego, California

Will contact sources of information in the boxing game in an effort to determine if DOLAN is or has been around San Diego. It is to be noted he told PAUL CLINITE that he planned to go to San Diego to see about opening a boxing stadium.

PHOENIX DIVISION - At Phoenix, Arizona

Will report results of thirty day mail cover placed on PAUL CLINITE.
