The source referred to in the enclosed letterhead memorandum is Special Agent WILLIAM MEREDITH of the Bell Telephone Company of Pennsylvania contacted by SA HAROLD L. STEVENS.

The Legat, Ottawa, Canada is requested to ask the RCMP to interview the subscriber to Montreal telephone number VI 9-0260 for the purpose of locating, identifying and ultimately interviewing JACK CROSO and "REPE" for details of the long distance telephone calls from the Ken Iron and Steel Company in New Kensington on 10/20/58. ~~(u)~~

As a matter of information and assistance the Legat, Ottawa should review letterhead memorandum dated 3/6/59 at Chicago, Ill., in the dual captioned cases entitled, "BERNARD J. EZHAYA, et al; FRANCESCO FERRARA - FUGITIVE; WILLIAM W. RABIN, Also Known As R. W. Emerson, W. W. Raybin, INTERSTATE TRANSPORTATION OF STOLEN PROPERTY - MAJOR THEFT;" "Unknown Subjects; Theft of \$2,250,000 Bearer Bonds, Unknown Amount Registered Bonds, Jewelry and Cash; Brockville Trust and Savings Company, Brockville, Ontario, Canada, May 3-4, 1958, INTERSTATE TRANSPORTATION OF STOLEN PROPERTY - MAJOR THEFT." ~~(u)~~
