Enclosed are the following communications received from the RCMP: Original and two copies of RCMP memorandum dated 7-20-59, enclosing three Photostats of RCMP Montreal Detachment report dated 7-6-59. (c)

Remarks:

Montreal telephone number VI 9-0260 registered to Metropole Club, Inc., which is described as one of the biggest gambling establishments in Montreal and is operated by Vincent Cotroni, brother of Guiseppe Cotroni, leader of narcotics ring who was arrested by the RCMP. RCMP advise telephone calls on 10-28-58, probably for "Pepe" Cocolichio, instead of "Repe," as referred to in report from Pittsburgh; and to Jack Croce, rather than to Jack Croco. RCMP point out that Cocolichio is manager of club and handles telephone messages between American racketeers and the Cotroni brothers and Croce, who is assistant manager, is known as a gambler and close associate of the Cotronis. In view of above, RCMP advise no interviews contemplated. (c)
