HAVE<sup>33</sup> DISCREETLY LOCATED ANTONIO ZAMBRANA VALDEZ RESIDING NAZARENO STREET CORNER OF VALDES VIDAL, REPARTO DEBECHÉ, GUANABACOA, HAVANA, CUBA. PRESENTLY WORKS STREET AND HIGHWAY CONTRACTS FOR CUBAN GOVERNMENT. DUE TO PRESENT EXTREMELY ANTAGONISTIC ATTITUDE CASTRO GOVERNMENT TOWARDS UNITED STATES RECOMMEND NO OFFICER OF AMERICAN EMBASSY INTERVIEW ZAMBRANA. HAVANA CABLE JANUARY 4 LAST INDICATED CUBAN GOVERNMENT WANTS DETAILED EXPLANATION OF NATURE OF CASE AND OFFICIAL NOTE FROM UNITED STATES EMBASSY TO FOREIGN RELATIONS REQUESTING ASSISTANCE. REACTION OF ZAMBRANA TO INTERVIEW NOT PREDICTABLE BUT MAY ASSUME HE WOULD IMMEDIATELY REPORT SAME TO CUBAN GOVERNMENT. UACB NOT REQUESTING EMBASSY ARRANGE FOR INTERVIEW. ~~(u)~~
