FOR THE INFORMATION OF THE BUREAU, A MIAMI SOURCE WHO HAS PROVIDED RELIABLE INFORMATION IN THE PAST, ADVISED THAT A SECRET MEETING WAS HELD ON MAY 8, 1976, AT THE AIRPORT HOLIDAY INN, LOCATED NEAR MIAMI INTERNATIONAL AIRPORT. SOURCE ADVISED ON MAY 27, 1976, THAT THE FOLLOWING PEOPLE ATTENDED THE MEETING, WHICH WAS HELD FOR THE PURPOSE OF ORGANIZING A SECRET ANTI-CASTRO GROUP, WHICH UP TO THIS DAY, DOES NOT HAVE A NAME:

MANUEL "MANOLO" CAMARGO, PRESIDENT OF INDUSTRIAS K.C. DE MEXICO, MEXICO CITY, D.F.; ARMANDO LOPEZ-ESTPADA - CURRENT MILITARY DIRECTOR OF THE BRIGADE 2506; ROBERTO CARBALLO - CURRENT PRESIDENT OF THE BRIGADE 2506; MARTINEZ ECHENIQUE - EX-PRESIDENT OF THE BRIGADE 2506; BERNARDO G. DE TORRES - EX-MILITARY DIRECTOR OF THE BRIGADE 2506; HUGO OLAZABAL - MEMBER OF THE BOARD OF DIRECTORS OF THE BRIGADE 2506; (FNU) *Signature*

AND IN COLOMBIA WHICH WERE WILLING TO COOPERATE ALSO IN THE SAME WAY AS THE DOCTOR FROM VENEZUELA.

AT THE TERMINATION OF THE MEETING, DISCUSSION REGARDING A PLAN TO ASSASSINATE FIDEL CASTRO ON HIS UPCOMING ALLEGED TRIP TO MEXICO CITY ON JUNE 8, 1976, TOOK PLACE. NO OTHER INFORMATION WAS GIVEN REGARDING INSTANT ASSASSINATION ATTEMPT PLAN BY CAMARGO, WHO HAD INSTITUTED SAID DISCUSSION.

SOURCE ADVISED THAT CAMARGO HAD STATED TO HIM THAT HE WOULD RETURN TO MIAMI IN EARLY JUNE AND WOULD SET UP ANOTHER "MEETING" WITH ALL OF THE ABOVE-MENTIONED INDIVIDUALS PLUS MORE, TO TALK MORE ABOUT THIS NEWLY-FORMED SECRET ORGANIZATION. (S)(u)

MM [4086-0A] IS ALSO BEING UTILIZED IN (S) [A DOUBLE (S)] AGENT OPERATION (S) AND IS AWAITING [CONTACT BY CUBAN INTELLIGENCE SERVICE] (S) IN ORDER TO [BE RECRUITED] BY SAME IN [AN ESPIONAGE (S)] CAPACITY.
