No local distribution was made of this report in view of the fact that local distribution might tend to disclose the activities of our source. However, there is no objection to any distribution desired by the Bureau at the Seat of Government.

This case is being closed at the present time due to the relative inactivity and lack of importance at this time of the JSP. However, in the event the activities of the JSP increase in importance, this case will be reopened and the new activities of the JSP followed closely. In the meantime the activities of the JSP will be followed by us in connection with the investigation we have relative to the Communist Party of Cuba.
