The identity of this person apparently has not been known and for that reason this office has been especially alert in routine contacts with police sources to see if the name was ever mentioned. EXCEPS ALL INFORMATION CONTAINED HEREIN IS UNCLACSIFIED EXC On 1-8-53, ex-National Police Lieutenant Jose Antonio ASecco Fernandez, who is presently working for the Cuban Minister of Defense as a SSFV special investigator of political (anti-Batista) activities, was in the OTHEAWISE office on another matter. In the course of a general conversation he mentioned that he had been told a few days ago by a source whom he did not S identify that about a month ago a very important opposition meeting was held on a farm not too far from the City of Havana but outside of Havana, SHOWN Province. Secco said he has not been able to ascertain the exact hocation OD CVB4 of this farm but that he was told that among those present, were MaxAlesnick, leader in the Orthodox Party youth section, Millo, Ochoa, one of the 122 principal leaders of the Orthodox Party, and a person called "YEKO," whom source identified to Secco as Aureliano Sanchez Arango, former Minister of Education during the Prio regime and well known as probably the most outstanding advocate of immediate and violent action on the part of the opposition against Batista. .Jo From a review of the summaries of information furnished by Source 6 in this matter and forwarded by the Bureau to this office, it CE would appear that the "YEYO" mentioned in the information could well be Sanchez Arango, the "YEYO" of the messages apparently being a person of some importance. It will be recalled that in early May, 1952, Sanchez Arango and ex-National Police Captain Raul Rodriguez Santos, departed Miami in an airplane piloted by notorious alien smuggler Edward William Murphy. They first went to Nassau and presumably after leaving the latter place, Sanchez Arango and Rodriguez Santos were landed by Murphy at some isolated spot in the eastern part of Cuba. Since that time, there have been repeated and consistent rumors that Sanchez Arango has been in and out of Cuba, although local authorites have been unsuccessful in their efforts to capture him. In connection with the meeting mentioned above at which leaders of the Orthodox Party and Sanchez Arango were allegedly present, it is interesting to note that according to information received from local American Legion contacts, Jose Antonie Quarte vioropesa, young Cuban recently arrested in New York in connection with the discovery of a storage of arms, is a member of the Orthodox Party and according to sources, was a very outspoken advocate of violent action prior to his leaving Cuba. The Orthodox Party publicly follows a line of more or less complete isolation from other political parties; but it would appear that within the party, there are elements which desire direct action and who are not hesitating to deal with representatives of other parties such as the Autentico Party of Prio and Sanchez Arango.
