Enclosed for the information of the Miami and New York Offices are two copies each of Mexico City letter dated 1/30/75.

Re Mexico City letter dated 2/30/75, LHM dated 3/22/71, and LHM dated 10/22/68.

Referenced Mexico City letter sets forth information indicating captioned subject was arrested at Panama City, Panama, on 1/22/75. At the time of his arrest subject had in his possession a New York driver's license and various charge account cards along with other documents which indicated he had been residing in the United States. driver's ligerse carried by the subject was in the name of ROBRENO, 491 West 22nd Street, New York, New York FERNANDO A. Subject stated that FERNANDO was a brother who formerly resided in New York but who now resides in Miami, Florida exact address unknown but having telephone 305-552-0770.

Referenced Miami LHM of 3/22/71 indicates that subject was a member of the July 26th terrorist movement in Cuba and that after the takeover by FIDEL CASTRO subject was named a captain in a Cuban rebel army. Subject acted as a presiding judge over numerous trials of "counterrevolutionaries many of which resulted in execution of the defendants.

In October, 1961, subject shot a member of the U. Embassy in Havana, Cuba. Subject was arrested but was later released. Subject also reportedly shot a U.S. Marine guard in front of the United States Embassy at Havana during an INLETTICI RECEST argument.

Subject in the early 1960's departed Cuba for Madrid, Spain. It was never explained as to the manner of which he was able to divorce himself from the Cuban government and obtain permission to leave Cuba.

Subject's father in 1971 was employed by Replica", a Miami Cuban exile newspaper owned and operated by one MAX LESNICK, who currently supports the CASTRO regime and who Cukan has been investigated by the Miami Office.
