was approached by MIKE GENOVESE, protege of LA ROCCA, to extend credit to FONTANA and assist him in getting started. The informant knows that about \$7,000 worth of merchandise has been sold to FONTANA already but does not know whether the LA ROCCA-GENOVESE organization is financially interested in this legitimate business enterprise or not.

CTE of the Pittsburgh Division has advised that the MANNARINO organization is in serious financial trouble and is trying to raise money to hire a top attorney to represent the organization in the trial involving the Internal Revenue Service at Pittsburgh. Attempts to hire BENNETT WILLIAMS have been unsuccessful because of lack of ready money and this informant has advised that MANNARINO requested the assistance of LA ROCCA in this matter. LA ROCCA allegedly told MANNARINO that he should take care of his own house.
