WEEKLY AIRTEL SUMMARY

LA ROCCA remains in the Pittsburgh, Pa., vicinity according to neighbors at Ingomar, Pa., and informants who advise that his adopted son is now attending Point Park Junior College in Pittsburgh and has moved into a new residence at 511 Guenevere Drive, North Hills section of Pittsburgh. Educational and living expenses are ostensibly being handled by LA ROCCA.

A Pittsburgh informant has observed LA ROCCA driving a 1961 Oldsmobile bearing Pennsylvania license Y59317 in the vicinity of the residence of JOSEPH SICA, known Pittsburgh racketeer who resides at 1003 Lincoln Highway, East McKeesport, Pa. This automobile was also observed parked at that residence by the aforementioned informant. The vehicle is registered to MARY S. LA ROCCA, 900 West Ingomar Street, Pittsburgh 37, Pa.

Another informant has advised that during August, 1962, JOHN FONTANA, lieutenant, MANNARINO organization, New Kensington, Pa., opened a jewelry store and discount house on Frankstown Avenue in the East Liberty section of Pittsburgh. This informant

was approached by MIKE GENOVESE, protege of LA ROCCA, to extend credit to FONTANA and assist him in getting started. The informant knows that about \$7,000 worth of merchandise has been sold to FONTANA already but does not know whether the LA ROCCA-GENOVESE organization is financially interested in this legitimate business enterprise or not.

CTE of the Pittsburgh Division has advised that the MANNARINO organization is in serious financial trouble and is trying to raise money to hire a top attorney to represent the organization in the trial involving the Internal Revenue Service at Pittsburgh. Attempts to hire BENNETT WILLIAMS have been unsuccessful because of lack of ready money and this informant has advised that MANNARINO requested the assistance of LA ROCCA in this matter. LA ROCCA allegedly told MANNARINO that he should take care of his own house.

SUBJECT SHOULD BE CONSIDERED ARMED AND DANGEROUS.
