Since the submission of the last FD-143 on 6/26/62, information has come to the Pittsburgh Office concerning the possibility of the placement of a burglar alarm system, a high anchor fence and strands of barbed wire at the North Star Cement Block Company. It appears that this relates only to the rash of burglaries and equipment thefts being experienced by North Star and other plants in that immediate vicinity. No action has been taken in this regard as yet.

PG 622-C* was discontinued on 6/11/62, and was re-activated on 6/29/62, after inductance and cross-talk on the lines were eliminated. On that date, during discussion it was learned that the North Star Cement Block Company had undergone a change in officer titles, and that while SEBASTIAN JOHN LA ROCCA was still President, ALDO PRUNER is now Vice-President, ROY L. VEY is Treasurer, and JOHN CONTI is Assistant Treasurer. If any salary adjustments are noted in this regard a suitable time lapse will be observed prior to the notification of the Internal Revenue Service at Pittsburgh, Pa.

On 7/12/62, it was noted that JOHN LA ROCCA, the adopted son of SEBASTIAN JOHN LA ROCCA, had again commensed work as an auditor at the North Star Cement Block Company, and that this job was to be held by him until his college term began in 9/62.

It was noted on 7/27/62, that LAeROCCA had purchased a home for this adopted son and the names of the realtor, insurance, and banking officials involved in the transaction were obtained.

On 8/28/62, it was learned that the North Star Cement Block Company owes \$40,000 to an individual and \$38,000 to another company, and that the company has approximately \$125,000 in accounts receivable. It was learned that the company is borrowing \$40,000, and that company officials are becoming disturbed at the lack of genuine interest shown in relation to their financial difficulties by LA ROCCA, who seems to be the only one making money out of the operation.
