PG T-1

This individual has access to records relating to those inhabitants of Villa Rosa, Italy.

PG T-2

This individual is a former associate of La Rocca who can furnish information relating to several of La Rocca's past financial interests.

PG T-3

This individual is a long-time numbers writer in New Kensington, Pennsylvania, who is personally familiar with most of the members of the Mannarino organization and with some of the gamblers from the Pittsburgh, Pennsylvania, area.

PG T-4

This individual is a thirty-four year old man who is a lifelong resident of the New Kensington, Pennsylvania, area who visits gambling establishments in the New Kensington and Pittsburgh, Pennsylvania, areas on a frequent basis.

PG T-5

This individual is extremely familiar with prostitution-type activities in the Pittsburgh area and has a speaking acquaintance with the members of both the La Rocca-Genovese and Mannarino organizations.
