- 6. Will continue to endeavor to develop a confidential informant at the North Star Cement Block Co., 12 McCandless St., inasmuch as LA ROCCA is presently spending most of the time that he is away from his residence at this location.
- 7. Will maintain contact with the Chief of Police of the McCandless Township Police Department and those officers covering the neighborhood in which LA ROCCA resides so that immediate notification by them may be made of any unusual activity observed in the vicinity of LA ROCCA's home.
- 8. Will check the list of toll calls made from Forest 4-5296, the home telephone of LA ROCCA, for the names of racket associates and personal business contacts of the subject not now known to the Pittsburgh Office and will further identify and obtain appropriate background information of subscribers to telephone numbers called.

CRIMINAL INFORMANT COVERAGE

The following individuals are presently being utilized by the Pittsburgh Office in the SEBASTIAN JOHN LA ROCCA investigation:

PG 573-C, who is extremely friendly with the GENOVESE brothers and particularly FIORE GENOVESE, younger brother of MIKE GENOVESE, and who is presently being utilized for the general coverage of the Red Eagle Club and its visitors.

PG 585-C, who is well acquainted with most of Pittsburgh's Top Hoodlums and who was formerly employed as a waitress in the Red Eagle Club, once known as the Genovese Cocktail Lounge, 412 Larimer Avenue, Pittsburgh. Informant still visits this establishment and comes in constant contact with MIKE GENOVESE and other members of Pittsburgh's racketeering element in her role as a medium-priced prostitute. Informant is presently traveling with Mrs. JULIA MINTZ, widow of JAKE MINTZ, co-owner of EZZARD CHARLES, former world's heavyweight boxing champion. She is presently being utilized for the coverage of the Genovese-LaRocca-Nelson interests.

In an effort to increase criminal informant coverage, the PCIs under development are being contacted on a continuing and regular basis so that information obtained from them may be used on a day-to-day basis in connection with spot surveillances of the establishments frequented by the subject when he is in the Pittsburgh vicinity.

PG T-1 is WILLIAM MEREDITH, Special Agent, Bell Telephone Company of Pennsylvania, who was contacted by IC GEORGE C. DIPPOLD on 5/12/60 and who has requested that his identity be concealed.

PG T92 is a Potential Criminal Informant of the Pittsburgh Office, who was contacted by SA ROBERT A. VOEGE on 4/4,15; 5/13/60.

the other racketeers feared and respected him because of his size and cold blooded attitude. He stated that in those days the moonshine concession in Pittsburgh's 13th Ward was run by a man named JOE GIGILLOTTI and that LA ROCCA was only a whiskey runner from Jamestown, N. Y. He recalled that SPINELLI non-drinker who was consequently hired as a body guard for the older three VOLPE brothers and that he had been born and raised in Italy where he had left his wife and two children. The informant said he knew that SPINELLI hired out as a professional gun man and that he owned some stills in the Pittsburgh area until he was crossed up in some manner by the VOLPE brothers who insisted that he was simply working for them. The informant stated that this so engaged SPINELLI that he vowed he would kill all three. He recalled that SPINELLI left the moonshine joint early one morning without telling the informant where he was going and that he later learned that SPINELLI had encountered the three VOLPE brothers eating breakfast at Bazzanno's Restaurant in Pittsburgh's Hill District at which time he gunned them to death. He recalled that ARTHUR and JIMMY died with their heads in their cereal but that JOHNNY managed to brush by SPINELLI and did not die until he reached the gutter in front of the restaurant.

The informant recalled that SPINELLI gathered his things together and immediately fled to New York where he encountered the brother of the BAZZANNO who ran the Pittsburgh restaurant. He stated that SPINELLI killed this individual with an ice pick and that newspaper accounts from New York told how BAZZANNO was discovered with more than 150 ice pick holes and with various sections of his body cut off. He said that SPINELLI then fled to Italy and had nerve enough to settle with his family in the same town in which the elder VOLPE was an official. He stated that the elder VOLPE was thereafter responsible for having SPINELLI sentenced to 25 years in an Italian prison because he could not be extradited to the U.S. He recalled that in those days numbers operations in the Pittsburgh area were incidental to moonshine operations and that most moonshiners carried a numbers card plainly visible in their back pockets. He stated that the police became interested in numbers only when moonshine was no longer profitable for them.

The informant further advised that independent bookies in the East Liberty - Homewood area are still being pressured by the Pittsburgh Police Department and that things have gotten so bad that he has been forced to contact his "joint" by telephone only. He added that even the smaller books turning into the Genovese-Nelson combine run a daily risk of being raided and must take meticulous precautions to avail detection.
