ReBuairtel of 1/26/61, granting authority for installation of Misur on subject's business, North Star Cement Block Company, Pittsburgh, Pennsylvania, and advising that a Bureau engineer would proceed to Pittsburgh to supervise installation as soon as final installation arrangements had been completed by Pittsburgh.

Installation of the above-mentioned Misur was completed on February 6, 1961, under the supervision of Laboratory Supervisor Ben L. Sutton. The installation consisted of a "MUTT" AC operated Radio Transmitter installed and concealed within the office space of the North Star Cement Block Company. An unattended Vega model radio receiver was installed in a secure manner within a Westinghouse plant building and approximately 400' from the "MUTT" for the purposes of receiving the "MUTT" signals and feeding those signals into a leased telephone line which terminated in the Pittsburgh Office central technical plant.

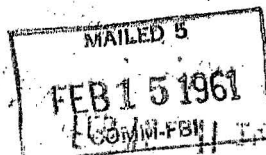
