HCS advised LA ROCCA is visiting Florida and it is believed he may be staying in the Miami vicinity. Pittsburgh informant acquainted with Miami area states there is a possibility LA ROCCA may be visiting at 8919 Dickens Ave., Surfside, Fla., the residence of GABRIEL "KELLY" MANNARINO, Pittsburgh and National Top Hoodlum.

Miami has been requested to ascertain whether LA ROCCA is visiting at the aforementioned address.

Miami is also being requested to contact reliable criminal informants in this regard. It is believed that [redacted] former Pittsburgh resident now residing Miami, may be of assistance in this regard.

IN VIEW OF THE CONVICTION OF LA ROCCA FOR ASSAULT WITH INTENT TO KILL AND HIS ARREST FOR CARRYING A CONCEALED WEAPON, HE MAY BE ARMED AND SHOULD BE CONSIDERED DANGEROUS.
