He stated that this construction job was operated out of a small business establishment located at 5830 Forward Street, in the Squirrel Hill Section of Pittsburgh. He said that FIORE GENOVESE, youngest brother of Apalachin attendee MIKE GENOVESE, has again assumed operation of the Red Eagle Club and its facilities. This informant is of the opinion that ROCCO is being prepared for a more important job in the organization, but could not elaborate on this conjecture.

C. ILLEGAL ACTIVITIES

Information of a Criminal Nature Obtained Through Informant Coverage.

PG T-3 has advised that the top racket men in the Pittsburgh, Pa. area do not meet at any specific location for each of their meetings or conferences, but that a number of social engagements, which are always attended by the top racket figures in the area, are held at the Phoenix Motel in Monroeville, Pa. He stated that these meetings are always attended by GABRIEL and SAMUEL MANNARINO, SEBASTIAN JOHN LA ROCCA, ARTHUR D. NELSON and their respective lieutenants. He stated that the lesser echelon figures usually attend a buffet prepared by the cook at the Phoenix Lounge on Thursday nights and that this is open to the public, with certain limitations.

The aforementioned informant advised that during a conversation with MIKE GENOVESE he was advised that JOSEPH PECORA managed the Jockey Club at Chester, W. Va., during the absence of CHARLES TEEMER. He was also advised that PECORA is definitely the MANNARINO organization's "boy," and is considered the lieutenant of GABRIEL MANNARINO. The informant said that one MICHAEL CAPIZZI is also employed at the Jockey Club and is known to associates as "WANGO. According to the informant, this individual is an understudy for PECORA and is considered his strong-arm man. When questioned concerning the location of horserooms in the Pittsburgh area, this informant advised that to the best of his knowledge, the only location at which one can place a horse bet is the Red Eagle Lounge at 412 Larimer Avenue. He did not think that there were any other horserooms in operation in the Pittsburgh area.
