Your request for authority to make an installation at LaRocca's home in Ingomar, Pennsylvania, appears to be premature. Informants and other sources should be able to furnish information as to where LaRocca conducts his racketeering activities or the identity of the person or persons who handle such affairs for him.

The Bureau cannot at this time authorize tesurs on matters such as this, however, if a kidnaping should occur or a life is definitely in danger involving a substantive violation over which we have jurisdiction, definite consideration would be given to utilization of a tesur.

If you are able to develop facts indicating LaRocca uses his home in connection with his racketeering activities, it would appear from your very detailed survey that consideration should be given to the use of a modified SPMT.

The modified SPMT application referred to is set forth under Special Applications, Page 188, Part I, Handbook of Technical Equipment.

NOTE: Pittsburgh is endeavoring to establish an additional tesur on LaRocca since he has been alleged to be the "Big Boss" while Vito Genevese is in jail.
