[] STATED THAT THE "BERTRAM" MODEL BOAT IS NAMED THE "JUANIN", AND IS A 31 FOOT BOAT WITH TWO, 275 HORSEPOWER CHRYSLER INBOARD MARINE ENGINES. THE JUANIN BELONGS TO THE DRE, AND IS MOORED IN SANTO DOMINGO TOGETHER WITH A SMALL PT TYPE BOAT OF THE DRE NAMED THE "SUSAN ANN." [] STATED THAT THE SUSAN ANN WAS THE PT BOAT USED BY THE DRE ON A RAID ON CUBA WHERE AN HAVANA THEATER WAS SHELLLED.
