Please refer to your 14220 dated 2nd April, 1963.

The authorities in the Bahamas report that the incidents related in your memorandum sound probable although there are minor discrepancies. ORANGE CAY is situated 18 miles South of SOUTH RIDING ROCK, and a position 60 miles to the South of the Cay is just north of the CAY SAL group. However, DOG BANK is not traced by that name and DOG CAY, DOG ROCKS, etc., are located in the EXUMA CAYS nearly 200 miles N.E. of CAY SAL. It is of course possible that a bank in the CAY SAL area is known locally as DOG BANK.

The Bahamas authorities state that it is true that more patrols have been carried out in the CAY SAL area, but these, with one exception, have been undertaken by the Royal Navy. There is no record that the "Alisan" was ever searched.

The authorities are naturally interested in the report in your third paragraph that the bomb used was made in the Bahamas. We shall be interested to know whether you have any further information to show whether the allegation is that this bomb was made in one of the Cuban revolutionary camps or whether there is any suggestion that Cubans resident in the Bahamas were involved.
