ReBulet dated 5/21/63 concerning report of SA  
GEORGE E. DAVIS, JR., dated 4/13/63 at Miami.

On 5/23/63, SANTIAGO ALVAREZ RODRIGUEZ was  
interviewed concerning bomb used in the 3/27/63 attack.  
He reiterated information previously furnished and set  
forth in referenced report. *qu*

He explained that the bomb was made in the Bahamas  
with material brought from the U. S. and made up on a  
deserted, unidentified island in the Bahamas. *qu*

He stated no Cuban revolutionary camp was involved,  
no Cuban residents of the Bahamas participated, and nobody  
outside of the participants in the 3/27/63 raid had any  
knowledge of this bomb. He declined to furnish further  
information concerning this matter. *qu*
