FLA Miami teletype 3/30/63 set forth the results of an interview conducted with Dr. Santiago Juan Antonio ~~Alvarez Rodriguez~~, who is more commonly known as Dr. Santiago ~~Alvarez~~, former Cuban Senator and owner of the "Alisan," a vessel which was involved in the 3/26/63 attack against Cuba. We indicated we were making dissemination to the Attorney General and that information provided by Alvarez dealing with activity in British territory was being furnished British.

Our letter to the Attorney General dated 4/1/63 captioned "Anti-Castro Activities" with enclosure set forth the results of our interview with Alvarez. *24*
