Comandos L (CL) is anti-Castro organization which has engaged in carrying out raids against Cuba in past.

On 10/26/66 San Juan informant advised he has been approached to captain "Angelina," Cuban exile sailing vessel, on infiltration mission to Cuba. Mission to be sponsored by CL in conjunction with two other anti-Castro organizations.

The "Angelina" will be utilized as a mother vessel to carry fuel for the "Pitirre," a CL speed boat, and would sail to a point some hundred miles from Cuban coast, from where several Cubans would be infiltrated into Cuba by speed boat. The "Angelina" would wait for the return of the "Pitirre" and the informant would not further participate in the infiltration mission and would not leave command of the "Angelina."

Informant advised he has been extremely reluctant to become involved in matters of this type but since his fellow Cubans have personally sought his help he feels a certain obligation to do something for his country, Cuba. He indicated that he would participate in these plans if we had no objection and if certain conditions dealing with the administration of the vessel are met by CL representatives. Informant has been advised that the FBI in no way backs any Cuban exile plans; that the FBI could not condone his actions; and any plans he has to participate in this activity would be made strictly on his own. Informant advised he understood this but would continue to furnish all data pertaining to this matter to us.
