On 10/26/66, SJ 627-S, who has provided reliable information in the past, advised that he has recently been approached within the past two days to captain the Cuban exile organization sailing vessel named the "Angelina" during a planned "raid" on Cuba. Source explained that it is desired that he take one month's leave of absence from his job and participate in these Comandos L plans. He explained that he has been extremely reluctant to participate in plans of this type in the past, but since his fellow Cubans have personally sought his help, he feels a certain obligation to do something for his country of Cuba. He said that he will participate in these plans if the FBI does not object and if three conditions are met by the Comandos L people, namely:

Source also pointed out a problem concerning his immigration status if he decides to participate in this "raid". He is in the United States as a refugee and presently his immigration papers are on file at the United States embassy in Santo Domingo.
