The LHM is classified "confidential" in order to protect the identity of informants of continuing value, the disclosure of whose identity could have a detrimental effect on national security interests.

ADMINISTRATIVE

On November 8, 1966, SJ 627-S-received a long distance telephone call from RAMON FONT SAUMELL, who was then in Miami, Florida. FONT requested that the necessary registration papers of the "Angelina" be forwarded to him so that the ship could be registered in the State of Florida. FONT said that he was very busy and that it would be around December, 1966, before he would arrive in San Juan, Puerto Rico.
