In relation to the above, it is noted that TONI is the name of BRODKIN's wife. The reference to BERKO is apparently a reference to LEO BERKOWICZ, an associate of STERNMAN in gambling in Montreal. HARRY GROSSMAN is believed to be a New York attorney who resides on Long Island. It is noted that BRODKIN has visited him and stayed on his estate in the past.

The remark by BRODKIN, "Are the inspectors still with you?" apparently refers to the fact that, as the Bureau is aware, STERNMAN is under active surveillance by the Royal Canadian Mounted Police. Apparently STERNMAN has learned of the investigation and surveillance of him by the RCMP.

Although the Chicago Office has considered paraphrasing the above conversation and placing it in a letterhead memorandum for possible dissemination to the RCMP, it is not felt that this can be done with adequate security to this source.
