It should be noted that IMRE LIPSCHER, aka EMERY LIPPAI, EMERICK LIPSCHER, [visited the Embassy of France, (s) Washington, D.C., on 6/6/63. He advised [RENE CORNE, Vice Consul, whom he knew in Havana, (s) that he arrived in the United States on 4/27/63, aboard a Red Cross ship. He indicated he was in Washington to seek help in finding a job. (X)(S)

It is noted that [CORNE] (s) is reported to be active in Intelligence work at the French Embassy. (X)(S)
