HARRY RAYMOND POPE, AKA, FUG., I.O. THREE TWO EIGHT FIVE, WF TWO
TWO NINE, PEGGY ANN FRYE, AKA, FUG., UFAP, BURGLARY, ADW, HARBORING.

RE NEW ORLEANS TEL AUGUST TWENTYTHREE. FISUR OF JELSEN AND PCI
EVEING OF AUGUST TWENTYTHREE DEVELOPED NO SIGNIFICANT CONTACTS
AND NEITHER WENT TO TONY BACINO-S BAR, NOW GASLIGHT BAR. DID
DRIVE EXTENSIVELY THROUGH FRENCH QUARTER, PASSING BAR TWICE WITHOUT
STOPPING. MADE SEVERAL PHONE CALLS FROM PAY STATIONS. NEITHER

GETTING HURT UNQUOTE. PCI TELEPHONED SA ALDEN SEVEN THIRTYFIVE PM AUGUST TWENTYFOUR SAYING JELSEN TOLD HER THINGS WERE TOO HOT TO OPERATE, THAT SHE WANTED HER TO GO TO FARMERSVILLE, TEXAS AND TALK TO JOE WYATT WHO CAN GET IN TOUCH WITH OR GET MONEY TO PEGGY.

SHOWED HER A NOTE SHE CLAIMED TO BE IN HANDWRITING OF PEGGY FRYE WITH NOTATION ON ENVELOPE QUOTE IF THIS ENVELOPE OPENED, BLOW THE WHOLE DEAL UNQUOTE. THE NOTE INDICATED PEGGY WANTED PCI TO GO TO FARMERSVILLE, TEXAS AND CONTACT JOE WYATT AT PHONE ST TWO DASH SIX TWO EIGHT ONE AND PCI TO GIVE PEGGY HER CAR AND PCI TO STAY WITH QUOTE MY FRIEND UNQUOTE WHILE PEGGY WENT SOMEWHERE ELSE.

JELSEN INSISTED PCI TEAR UP NOTE AND FLUSH DOWN TOILET WHICH SHE DID. PCI CLAIMED ENVELOPE RETRIEVED AND THROWN UNDER BED WITHOUT JELSEN OBSERVING. MOTEL ROOM SEARCHED BY AGENTS IMMEDIATELY AFTER DEPARTURE OF HOWARD AND JELSEN WITH NEGATIVE RESULTS. WOMEN SUDDENLY PACKED BELONGINGS AND DEPARTED MOTEL EIGHT FIFTEEN PM, APPARENTLY EN ROUTE TEXAS. BEING SURVEILLED BY DALLAS UNIT U DASH ONE HUNDRED AND NEW ORLEANS UNIT TWENTYSIX. DALLAS UNIT U DASH TWENTYFOUR DEPARTED NEW ORLEANS EIGHT FORTYFIVE PM AS UNIT WAS PARKED IN FRONT OF BAR IN FRENCH QUARTER. DALLAS TELEPHONICALLY ADVISED. SUBSEQUENT TO DEPARTURE OF WOMEN, NEGRO PORTER AT MOTEL

DALLAS JULY TWENTYNINE, FIFTYNINE. ON BACK OF ENVELOPE WRITTEN IN
INK IS QUOTE SEVEN THREE EIGHT TULUSE JOYCE THOMPSON UNQUOTE.
WOMEN LEFT MOTEL OWING BILL OF APPROXIMATELY EIGHTEEN DOLLARS.
PCI PAID ONE HUNDRED SIXTY^y DOLLARS BY THIS OFFICE PER BUREAU AUTH-
ORIZATION OF TWO HUNDRED DOLLARS TO DALLAS. MOTEL BILL WILL BE
PAID BY THIS OFFICE AND CONSIDERED AS ADDITIONAL PAYMENT TO PCI,
UACB. OKLAHOMA CITY ADVISED AIR MAIL. POPE IS HEAVILY ARMED AND
SHOULD BE CONSIDERED EXTREMELY DANGEROUS. FRYE IS ARMED WITH
THIRTYTWO CALIBER AUTOMATIC, HAS ASSAULTED POLICE OFFICERS IN THE
PAST AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS.
