HARRY RAYMOND POPE, AKA., FUGITIVE, IO THREE TWO EIGHT FIVE, WF TWO TWO NINE, UFAP BURGLARY, ADW.

RE OKLAHOMA CITY RADIOGRAM AND TELETYPE BOTH DATED AUGUST EIGHTEEN, LAST. AUTHORITY GRANTED TO PAY UP TO TWO HUNDRED DOLLARS EXPENSE MONEY, IF NEEDED, TO

PCI [ ] POPE ALLEGEDLY HAS IN HIS POSSESSION AT ALL TIMES A THREE FIVE SEVEN MAGNUM REVOLVER, FORTYFIVE CALIBER AUTOMATIC, THIRTYEIGHT CALIBER SNUB NOSE REVOLVER AND SAWED OFF SHOTGUN. HE SHOULD BE CONSIDERED ARMED

PCI [ ] received information that Peggy Ann Frye is very anxious to contact PCI [ ] Frye is a known associate of Pope and is believed to be with him at the present time. Frye requested PCI [ ] to come to home of Frye's sister in Dallas where Frye would make contact. PCI Howard has agreed to come to Dallas Friday night, 8/21/59 for this contact provided she can contact SA Charles F. Alden who is known to her and in whom she has complete confidence based upon previous contact. SA Alden is proceeding to Dallas to arrive shortly before PCI [ ] where he will report to SAC, Dallas and render all possible assistance in this case. Oklahoma City requested Bureau authority to pay additional \$200 expense money, if needed, to PCI [ ] who has been paid no money except for expenses to date. In view of strong possibility that Pope is with Frye at
