LANE, Jr., as well as for RALPH SERRANO and MITCHELL
WERBELL III mentioned in LHM.

For information of the Bureau and Legat,
Santo Domingo, Mr. ROBERT MOORE, Royal Bank of Canada,
Santurce, Puerto Rico, declined to make available
subject's bank records for review on 8/11/66.

Enclosed LHM is classified Confidential
inasmuch as the unauthorized disclosure of same could
possibly jeopardize national security and reveal a
highly sensitive investigative technique.
