For the information of FBI HQ and recipient Legats, the Atlanta Office received information from the Belgian Security Service per Legat, Paris, that on 10/25/74, a shipment of 3 cases of 146 kilograms of "SMG and suppressors, 6M PEN 9MM, 1M PEN 45, 26M 11/.380", arrived at National Airport, Zaventem, Belgium, for EDGARD M. LEMMENS, suspected supplier of arms to the Irish Republican Army and Euzkadita Azkatasunat, Basque terrorist group.] (S) *REC-9* [105-263921-3] (S)
