SA HUGUELEY advised that if information comes to his attention that [APIKIAN] or [AL-TAYYAR] or any representative of the [Iraq Government] contacts the MAC or the DSC in an attempt to purchase firearms or if information is received that any of the individuals may be contemplating travel to any foreign country in possible violation of the Neutrality Laws, that he will immediately notify the Atlanta Office of the FBI.
