MM T-1 is CALVIN BARTON BULL, 220 31st Street, Miami Beach, who appeared at the Miami Office on 1-29-68. BULL said he had information concerning the SNFE which he believed would be of interest to the FBI. He indicated that he would be glad to furnish any additional information which might come to him through his association with RONALD LEE AUGUSTINOVICH. Mr. BULL requested that his identity be concealed.

A new 134 file has been opened on BULL to investigate his potential as a Security Informant.

AUGUSTINOVICH is the subject of Bufile 62-110031. In 1961, he was active in Miami in an organization known as "Anti-Communist Legionnaires", Bufile 2-1693.

WERBELL, formerly involved in the operations of ROLANDO MASFERRER, is the subject of Bufile 62-108665.

With regard to the phosphorus, ammunition and arms mentioned in the LHM, BULL advised on 1-31-68, that AUGUSTINOVICH had implied that he would take BULL to the location where the SNFE is storing their war materials, within the next week or two.
