investigation in referenced airtel and LHM, 5/27/75, during
January, 1975, Special Agent GEORGE THOMAS, Bureau of
Alcohol, Tobacco and Firearms (BATF), Atlanta, Georgia,
advised that one GEORGE H. SALESKY and MITCHELL L. WERBELL,
III, were co-owners of Military Armament Corporation (MAC),
440 Glover, S.E., Marietta, Georgia, until approximately one
and one half years previously when they split and WERBELL
set up Defense Systems. SALESKY was still operating MAC at
this time, a competitor of Defense Systems, and has a Class
3 firearms license, which allows manufacture and export of
fully automatic weapons.
