On January 6, 1972, a knowledgeable source advised that JACK S. HORGER of Orangeburg, South Carolina, was attempting to recruit individuals as mercenaries for Father JEAN BAPTISTE GEORGES for the purpose of invading Haiti and overthrowing the Haitian Government. *15A*

On March 27, 1972, source advised the following:

S.C.
A member of the above-mentioned group, who is acting in the capacity of a liaison man, had been picked up by DEWITT HENRY WANNAMAKER, Assistant Chief of Police, Rutledge, Georgia, in front of the Continental Trailways Bus Station, 200 Spring Street, Northwest, Atlanta, Georgia, and taken to the Holiday Inn, Conyers, Georgia. WANNAMAKER informed the liaison man that he was valuable to the entire operation and that at 8:00 p.m. that evening (March 27, 1972), he (the liaison man) would receive a telephone call with further instructions. WANNAMAKER also told the liaison man that he (WANNAMAKER) could check on anyone through any police department. *IR DOB 9/20/42*

At approximately 6:30 p.m., March 27, 1972, the liaison man received a telephone call from LEN HORGER, son of JACK HORGER, and was told to immediately return to Columbia, South Carolina, and proceed to 3110 Duncan Street, Columbia. No reason was given; however, further instructions would be received upon his arrival in Columbia. *S.C.*

Source also advised that WANNAMAKER was to have provided two complete police uniforms, to include pistols, that the liaison man was to have taken to Columbia with him.

However, due to the short notice of the liaison man's departure, he was not given the uniforms or the weapons.

On March 27, 1972, Miss JO PRESSLEY, Identification Division, Atlanta Police Department, Atlanta, Georgia, advised that their records contained the following concerning HENRY DEWITT WANNAMAKER, JR.:

WANNAMAKER is described as a white male, born September 20, 1942, 5'10" in height, weighing 200 pounds, with blond hair and blue eyes. WANNAMAKER was arrested August 17, 1970 for driving while intoxicated and on November 28, 1970 for interfering with a police officer in the performance of his duty.

On March 27, 1972, JOHN H. SEAY, Agent, Georgia Bureau of Investigation (GBI), Atlanta, Georgia, advised that WANNAMAKER had been an informant for them but was dropped in September or October of 1971 because he was unreliable and attempting to get on anyone's informant list as long as they paid. At this time, SEAY believes that WANNAMAKER was still working for Alcohol, Tobacco, and Firearms (AT & F).

Additional information obtained by the Columbia Office of the FBI revealed that the liaison man had to leave Atlanta immediately because WANNAMAKER was reportedly under surveillance by the FBI and GBI. RAMON H. IVIE, Agent, GBI, who works Morgan County, Georgia, advised on March 29, 1972, that WANNAMAKER had applied to the Madison Police Department, Madison, Georgia, for employment. WANNAMAKER, IVIE advised, has an associate on the Madison Police Department by the name of JOHN DOUGLAS, who was fired from the Atlanta Police Department for reasons yet unknown. DOUGLAS has a farm in Rutledge, Georgia, and IVIE advised, several neighbors have registered complaints to the Rutledge Police Department concerning the sound of automatic weapons fire coming from DOUGLAS' farm.

On April 4, 1972, MITCHELL LIVINGSTON WER BELL, III, was interviewed by agents of the FBI at his home concerning his knowledge of Haitian affairs in general. He stated that since his involvement in ROLANDO ARCADIO, MASFERRER ROJAS' attempt to invade Haiti in 1966 - 1967, he has kept out of Haitian affairs. He was, however, contacted in January, 1970, by ANDREW ST. GEORGE concerning a French-oriented group in
