This will confirm State Department clearance granted orally through liaison for a discreet FBI investigation of the subject who is the Assistant Armed Forces Attache, Embassy of Israel, Washington, D. C. (S)

Confidential informants who have furnished reliable information in the past have advised that subject has been the main assistant at the Israeli Embassy to Brigadier General David Carmon, an Israeli intelligence officer at the same Embassy. Our investigation will endeavor to determine if subject is engaged in intelligence activities in the United States. (S)
