ReBulet dated 9-21-62, disclosing that [Bureau [S]]
Source [6] advised on 8-24-62, that on 8-23-62, Colonel
FRANK/MARSHALL was in El Salvador, accompanied by
Colonel JOSE PINEIRO PAEZ, FRANK M. AUSTIN, ARTHUR SMITH,
MICHAEL LIVINGSTON WERBELL, A. J. KANE, MANUEL FIRESTONE,
MANUEL FUEGO, MARSHALL R. DIGOS HANDY, MARIO GARCIA CONLY
AND LUCIOLO LUCHIEN, all of whom were believed to be
engaged in pro-CASTRO conspiratorial activities.

No data regarding the above individuals has
been developed by WFO in connection with current inquiries
being made in the MANUEL FUEGO case which would tend to
indicate the existence of an alleged twelve and one-half
million dollar check and that such a check has been or
eventually will be cashed.

In event such information is developed,
interested offices will be advised promptly.
