RE BUREAU TELETYPE TO SAN JUAN, 8/30/73.

VAN CLEAVE HAS BEEN KNOWN TO THE ATLANTA OFFICE FOR SEVERAL YEARS AS A TOP OFFICIAL OF ADVANCE SECURITY CORPORATION, AN ESTABLISHED INDUSTRIAL SECURITY ORGANISATION HOWEVER, APPROXIMATELY THREE MONTHS AGO VAN CLEAVE RESIGNED AND FORMED HIS OWN SECURITY COMPANY. THREE DAYS BEFORE HE DEPARTED FOR ARGENTINA, VAN CLEAVE VISITED ATLANTA SAC, ADVISED HE WAS UNDER CONTRACT TO COCA COLA EXPORT CORP. TO CONDUCT INQUIRY IN ARGENTINA WITH APPROPRIATE POLICE OFFICIALS IN THAT COUNTRY TO DETERMINE THEIR CAPABILITIES TO COPE WITH THREATS IN CONNECTION WITH EXTORTION DEMANDS AND VIOLANCE POTENTIAL AGAINST COMPANY OFFICIAL IN ARGENTINA, VAN CLEAVE NOTING THAT ONE MILLION DOLLAR DEMAND HAD BEEN MADE OF COMPANY BY ARGENTINA TERRORIST IN RECENT PAST. PURPOSE OF CLEAVE'S VISIT WAS TO REQUEST FROM SAC A "TO WHOM IT MAY CONCERN" LETTER STATING WHO VAN CLEAVE IS AND THAT HE WAS OF GOOD REPUTATION. HE STATED HE WOULD ATTEMPT TO OBTAIN SIMILAR LETTERS FROM OTHER
