"APPEX" (S)

(The above code name) has been assigned to a Cuban (S) alien (whose activities are being directed against) the Cuban (S) Intelligence Service. He has been given the assignment (by his Cuban principal) of obtaining information relating (S) to anti-Castro activities against Cuba. Through his contacts with members of the anti-Castro element in Miami, Florida, he has obtained the following information: (S)

1. Equipment of the Cuban exile organization Junta Revolucionaria Cubana (Cuban Revolutionary Junta) (JURE), formerly under control of JOSE RABEL, past commander of the JURE boat "Venus", is currently stored at the Hainai Naval Base in the Dominican Republic, located 14 kilometers from downtown Santo Domingo. This equipment consists of .50 caliber machineguns, a recoilless cannon, numerous small arms, ammunition and explosives, estimated worth \$8,000 to \$10,000 (S)(U)

2. Another Cuban exile organization, Movimiento Democratico Cristiano (Christian Democratic Movement) (MDC), maintains a "sigma" boat in the Dominican Republic, which is currently being used for fishing at the Bay of Manzanillo in the Dominican Republic. (S)(U)

It is requested that (clearance be granted for (S) him to) furnish this data to (his Cuban principal) (S)

The above data should not be further disseminated.
