On March 20, 1964, WALLY SONNEBERG, Kettle Falls, Washington, (Protect Identity), made available a tape recording he received from ROBERT DePUGH, Norborne, Missouri, National Coordinator of captioned organization. The tape is described as "meeting tape No. 5" and according to SONNEBERG, it is prepared by headquarters of Minutemen and mailed to all Minutemen groups in the country.

The following message is on this tape:

"This is meeting tape No. 5, prepared for distribution March 1, 1964."

"Fellow Patriots, this is National Coordinator BOB DePUGH. In preparing our meeting tape this month, we are going to do something that we have not previously done. Due to the serious situation posed by the recent investigation of our organization, I am going to take the liberty of sending one of these meeting tapes to each of you who have ordered any of the meeting tapes in the past, even though we may not have a specific order for this particular tape.
