- ADMINISTRATIVE -

This report is classified secret because it contains information [from CIA which has been classified by that agency as secret] and in the event of down-grading it is suggested this report always remain classified as confidential in view of the fact that it contains information from a Legat of the United States, thus reflecting Bureau investigative interest outside of the territorial limitations of the United States. (u) (S)

Consideration at one time was given to possible development of subject as a PSI in connection with Cuban matters due to subject's voluntarily furnishing information upon and subsequent to his arrival in the United States in 1959. However, subject was dropped from such consideration upon receipt of information that he had been involved in two murders (Bureau letter to Legat, Havana, 9/4/59).

It should be noted that the source that furnished the letter which subject sent to Cuba Police Chief EFIGENIO AMEIJERAS, was PSI RICARDO MADAN (MM T-3 in this report).

It was deemed advisable to present the material set forth in this manner to further protect MADAN, who knows the subject and who is also the individual to whom subject's mother turned for assistance in effecting the escape of the subject out of Cuba on one occasion.
