The Bureau is aware of known efforts of the organized criminal element to penetrate the Atlanta, Georgia area. The following information is submitted to summarize what is known concerning these efforts and to inform the Bureau of recent developments.

CRIMINAL INTELLIGENCE PROGRAM, ATLANTA DIVISION
ATLANTA FILE 94-425

Investigation has disclosed that MAX EDER, aka, Max Raymond, and JACK RUBIN from Miami, Florida, were registered at the Atlanta Cabana Motel, Atlanta, Georgia, 1/7-8/65. EDER according to information provided by the Miami Division is believed to be in connection with MIKE COPPOLA, who at the present time resides in Miami Beach, Florida, and is reported to be Caporegima in the Vito Genevese family of La Cosa Nostra.

Confidential informant AT 177-C has advised that EDER and RUBIN had lunch with IRVING BERLIN (a prominent Atlanta bookmaker) on 1/8/65. On 1/12/65, JOHN OWEN TYLER, a prominent Atlanta gambler, advised Bureau Agents during an interview that MAX EDER, aka. Max Raymond, from Miami

Full *Bob Stanley*
Beach, Florida, was in Atlanta and had contacted ROBERT ELI STANLEY (a prominent Atlanta lottery operator with other varied gambling interests) on 1/7/65. According to TYLER, STANLEY told him that EDER was in Atlanta for the purpose of locating property on which he might construct duplexes. TYLER disclaimed any knowledge that either EDER or RUBIN had indicated an interest in gambling activity to STANLEY.

Barney Information provided by the Boston Division suggests that the La Cosa Nostra family, headed by RAYMOND L. S. PATRIARCA, is interested in gaining a foothold in Atlanta, Georgia, and further that VINCENT TERESA and BARNEY VILLANI were sent to Atlanta by this group to investigate the feasibility of this action. In this regard, a Boston informant reports that HENRY TAMELO, Chief Lieutenant for PATRIARCA, stated that he had learned the details concerning the Atlanta bookmaking situation from MAX RAYMOND of Miami, Florida. *Miami*

Confidential informant BS 812-C-TE reported that while in Atlanta, TERESA and VILLANI contacted BOB STANLEY, who agreed to be "a partner in an organized venture". This informant states that contacts were also made with bookmakers IRVING BERLIN and TOM HENDRICKSON, who also "were agreeable to the organization of all bookmakers by the Boston group." *M.I.A.*

As noted above, ROBERT ELI STANLEY and IRVING BERLIN are well-known to the Atlanta Division, however, TOM HENDRICKSON is unknown to this office. A separate investigation has been initiated in respect to HENDRICKSON (AT 92-490), however, investigation to date which includes contacts with reliable informants who are knowledgeable concerning the Atlanta gambling element has failed to establish the existence of such an individual.

By communication dated 3/5/65, the Boston Division has been requested to recontact confidential informant BS 812-C-TE for more specific details concerning the meetings of TERESA and VILLANI with Atlanta gamblers. Boston has
